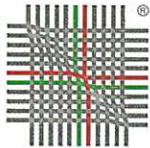

Yellow/Orange coverall with vertical front opening, elasticated wrists and ankles, elasticated hood; white textile zippers with 2 sliders (internal) and simple external zipper. Heat sealed seams with tapes, with knee pads.

Material: Polyethylene laminated+3 layers polypropylene
56% SMS Polypropylene – 44% polyethylene, 90 g/m²

Knee pads: 1 layer of the same fabric as coverall + 2 layer of SMS fabric.

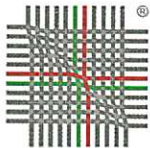

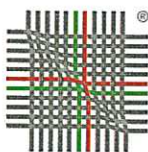

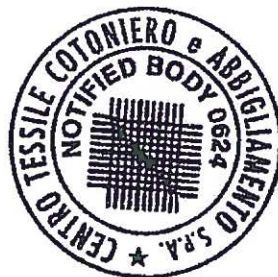
Validity
